1. INTRODUCTION

This Cookie Policy explains how WARVARG GAMES L.L.C-FZ ("we", "us", "our") uses cookies and similar tracking technologies on our websites.

This Policy is an integral part of our Privacy Policy.

Strictly necessary cookies are essential for the website to function and do not require your consent. All other cookies (e.g., for analytics and marketing) are used only with your explicit consent, which you can give, refuse, or manage at any time via the cookie banner or the persistent "Manage Cookies" link in the website footer.

3. WHAT IS A COOKIE?

A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server. We also use similar technologies (e.g., pixels, local storage, device identifiers used by analytics/ads tags). We refer to them collectively as "cookies".

4. WHAT DO WE USE COOKIES FOR?

We use cookies for the following purposes:

- to better understand your preferences,
- to help you navigate our website,
- to personalize and provide a more convenient experience to you,
- to analyze which pages you visit, and
- to measure advertising and promotional effectiveness.

We use: (a) strictly necessary cookies (security, load balancing, session); (b) analytics cookies with your consent to measure and improve our site; (c) marketing cookies with your consent to deliver or measure advertising; (d) preferences cookies to remember your settings.

For users identified as minors by our age-gate, marketing cookies are off by default; analytics use is minimized.

5. WHAT DATA DO WE PROCESS?

We process limited device and usage data (e.g., IP truncated to region, browser/OS, pages viewed) only where required to provide the site or where you consent. You can withdraw or change your choices any time via the banner or the persistent "Manage Cookies" link in the footer; we also honor Global Privacy Control (GPC) signals as an opt-out for marketing. Retention matches each cookie's lifetime in the Cookie List below (backups and logs follow our Privacy Policy).

Our purposes to process this information is to understand better your preferences, to help you navigate our website, to personalize and to provide more convenient experience to you, to analyze which pages you visit, and to measure advertising and promotional effectiveness.

6. COOKIE LIST

For material changes we notify in-app and on website at least 15 days in advance and request active consent in-app (for example, via a new checkbox or consent prompt) before continuing processing where required.
